Introduction

The ACT Housing Strategy was released in October 2018 to guide the delivery of housing in the ACT over its 10-year lifespan. Since then, significant progress has been made across the housing continuum, and the Government has adopted a new Implementation Plan to ensure priorities remain current.

The updated Implementation Plan builds on achievements since 2018 and outlines clear actions for the remaining period from 2026-2028. It replaces previous versions and provides a refreshed framework for delivering housing outcomes, with the following five goals guiding this work:



Goal 1. Expanding housing choice



Goal 2. Reducing homelessness



Goal 3. Boosting social housing



Goal 4. Improving rental housing



Goal 5. Supporting home ownership

This Report Card reflects progress against the updated Implementation Plan and highlights key achievements and case studies that demonstrate the ACT Government's commitment to delivering housing solutions for a growing and diverse community.





Case Studies

Expanding housing choice: Acton Waterfront Renewal

The Acton Waterfront project demonstrates the ACT Government's commitment to creating vibrant, inclusive, mixed-use precincts. Master planning and community consultation have shaped a design that integrates housing diversity with cultural and recreational spaces. This renewal initiative will deliver new housing options alongside public amenities, supporting a sustainable and inclusive city centre.

Reducing homelessness: Woden Youth Foyer

The Youth Foyer in Woden provides 20 independent living units for young people aged 16–24 who are committed to education and training but are at risk of homelessness.

Integrated with the new CIT campus, the Foyer will offer wrap-around support services, helping young people achieve stability and independence while pursuing their education.

Boosting social housing: Growing and Renewing Public Housing Program and Commonwealth Funding

The Growing and Renewing Public Housing Program delivered 213 new public housing dwellings in Year 6 and advanced 312 homes in the construction pipeline, keeping the program on track to meet renewal and growth targets.

Under the Social Housing Accelerator, contracts were executed for 41 dwellings, with completion forecast for 2026. Funding was secured through the Housing Australia Future Fund Facility Round Two for 85 social housing dwellings.

Supporting home ownership: Help to Buy Program

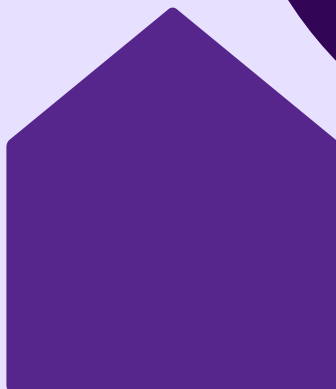
The Help to Buy program complements ACT initiatives by providing shared equity opportunities for low- and middle-income households. Expected to assist 700 ACT households over four years, the program reduces upfront costs and helps eligible buyers enter the housing market sooner.

Improving rental housing: Affordable Community Housing Land Tax Exemption Scheme

Through this Scheme, property owners who rent their homes at less than 75 per cent of market rent through registered Community Housing Providers can get an exemption from paying land tax.

The ACT Government expanded the property cap from 250 to 1,000 and introduced a \$500,000 grant program to support Community Housing Providers in growing and improving the Scheme.

Providing over \$8 million in funding for women's services, including specialist homelessness services targeted at those escaping family and domestic violence, such as Beryl Women's Refuge and McKillop House, Doris Women's Refuge, Mackillop House and transitional accommodation managed by Toora Women. Supporting emergency hotel accommodation and court advocacy services through the Domestic Violence Crisis Service (DVCS). Funding a new initiative to provide additional housing options for women with children who are experiencing family and domestic violence. Delivered by Marymead CatholicCare, DVCS and Yerrabi Yurwang (an Aboriginal Community-Controlled Organisation), the crisis and transitional accommodation program includes the purchase of eight units and houses and will include wraparound supports from these three local providers. Each eligible household may apply for a one-off grant of \$400 to undertake activities to increase community participation.</p> <p>In 2025-26, Tenant Participation Grants have provided funding to 121 households.
